PLEASE NOTE THAT THE TRIAL WILL NOT BE RUN WITHOUT A MINIMUM OF 6 DOGS DUE TO SET UP AND TRIAL NEEDS. PLEASE SEND ENTRIES AS SOON AS POSSIBLE.

HOUNDS WILL NOT BE PERMITTED TO ENTER WITHOUT A COMPLETED AND SIGNED ENTRY FORM. FOR FIRST TIME ENTERED HOUNDS (FTE), A COMPLETED ENTRY INCLUDES THE PHOTOCOPY OF THE DOG'S REGISTRATION AND A ONE-TIME \$2 REGISTRATION FEE IN ADDITION TO THE ENTRY COSTS.

Pre-entries: \$25.00 per dog (please include \$2 for FTE). Pre-entries close Thursday, October 3 at 5:00 pm. Pre-entries may be made by phone, e-mail, or snail mail to the Race Secretary listed below.

Same-day entries: \$30 per dog (plus \$2 for FTE). Entries close 8:15 am on Saturday, October 4 at the Race Secretary's table located at the Wyomissing Soccer Field under the pavilion.

PayPal Payment - Entries can be made via PayPal to IWADV (payment link on IWADV.org). Please add \$1.00 convenience charge per entry and include receipt of payment with entry form. Convenience fees are a PayPal fee and not income for DeVal. If you are entering the specialty, only one payment is needed for entry to both - just add LGRA costs to conformation total.

Race meets will be 3 program, 4 dog races, 200-yard straight sprints. NOTE: All dogs will be hand slipped.

All dogs must run with muzzles and racing blankets. A small number of muzzles and blankets will be available for loan.

ELIGIBILITY

Hounds must be one year of age or older to be eligible and must not be lame, sick, or in season.

Each hound must be individually registered with the American Kennel Club (AKC), Canadian Kennel Club (CKC), or the United Kennel Club (UKC). Hounds registered with the AKC under Indefinite Listing Privilege (ILP) or the CKC equivalent may also be entered.

Each hound must have a completed and signed entry form. Those with First Time Entered (FTE) hounds must attach a photocopy of your dog's registration to your entry form, along with a one-time \$2.00 registration fee.

HOUNDS WILL NOT BE PERMITTED TO ENTER WITHOUT A COMPLETED AND SIGNED ENTRY FORM. A COMPLETED ENTRY INCLUDES THE PHOTOCOPY OF THE DOGS REGISTRATION FOR FTES!!!
